**Product Description:** Argos Education's (Argos) platform provides an end-to-end platform for the creation, adoption, delivery, and improvement of adaptive digital learning experiences. Educators and course designers can use Argos to select existing course products, create brand new products, and modify existing products to suit their specific teaching objectives. Argos's authoring tool and content and tools marketplace gives educators and designers everything they need to create pedagogically sound learning experiences that capture learner interaction data to drive feedback loops for learners, educators, and researchers. The platform can operate in stand-alone mode or via LTI integration. Much of Argos's code is based on the Open Learning Initiative's open-source software project known as Torus. Torus development continues as an open-source project with major contributions from Carnegie Mellon University, Arizona State University, Argos Education, and Unicon, Inc. among others.

**Notes:** This conformance report focuses exclusively on the affordances and capabilities of the Argos delivery platform and its natively supported content types. Because content for courses delivered on Argos is developed and revised by a large, diverse community of educators and learning designers, specific content within courses may not leverage the platform in a full conforming manner. Typically, these issues are corrected within courses as they are identified, as the content owner and delivering educator seek to constantly improve their learning experiences. Similarly, many courses in the Argos marketplace incorporate third-party activities like labs and simulations and may deviate from OLI standards.

Argos and the OLI open-source community constant strives to ensure that the technology and learning experiences it delivers is as accessible as possible. A key tenet of Argos is to give educators and designers a place where end-to-end creation and delivery is specifically designed for both the introduction of many contributors to expand the available content and services while simultaneously improving the learner experience and assuring the highest levels of accessibility support.
